NEW Policies and Procedures due to COVID-19 and Social Distancing Guidelines are listed below

- Everyone stays 6ft apart beside the crew and family you came in with.
- No gatherings larger than 10 people and social distancing will be strictly enforced
- Absolutely no gatherings outside of the crew you came in with.
- No one permitted in tower besides essential employees.
- Only two accompanying crew members per golf cart and in the staging lane area with your car. As soon as your car has made its pass, all accompanying crew is to exit the starting line and staging lane area.
- Please limit your travel around the grounds and pits to essential needs. Help keep family members, pets and crew contained to your own pit area.
- Overnight parking is still permitted if necessary. But please continue to adhere to social distancing standards and guidelines after hours as well until further notice is provided and permitted.

ESSENTIAL SERVICES PROVIDED:

- Food & Beverage Sales –
- Fuel and Oil Sales
- Technical Inspections
- Church & Prayer Services over the PA system while you remain in your parking areas

*We will follow strictly the guidelines of Social Distancing outlined by the CDC. By following this outline and showing compassion for following rules, it will ultimately demonstrate that we as a racing community can operate in an outdoor venue safely and respectfully. Please keep your radios tuned to 95.5 for continued updates and further instruction throughout the day.

**We also highly suggest turning off the Location Services on your phone. Help keep our GPS locations from appearing to be something they are not, since we know this service is being used to track large gatherings and crowds. Do your part to help avoid negative feedback and influences from social media. Although we are all excited to be engaging Drag Racing or as we call it “Essential Services and Business”, pictures, conversation and exposure to Social Media are not useful in our efforts at this time. Take all of the pictures and video you want. But help us minimize the spread of false or negative information that extends beyond our community. Thank you!

OTHER IMPORTANT PROCEDURAL INFORMATION:

- Workers will receive a temperature check before beginning their shift and duties.
- Facilities contact surfaces will be cleaned thoroughly and regularly throughout the day.
- The tower will be restricted-access only and limited to essential staff.
- Time slip workers may wear masks and gloves for the distribution of time slips.
- The process of payouts for events will be adjusted. We will be offering a mail in option that will take place immediately following the event. In order to keep up with these processes this year, we will need for you to fill out a W-9 (downloaded on our website). This is necessary before payouts can be given.
- All of our Portapotties will be equipped with hand sanitizing dispensers.
- Fuel & Oil Sales will also follow social distancing.
- Staging lanes/Starting line Fence: This is our main congregating area for crewmembers and their families. We will be implementing policies and procedures for this area with access limited to one to two crewmembers per car who will be limited on their time in the area. Our staff, starting line crew and ambulance staff will closely monitor this area to prevent any unauthorized gathering.
- Please be respectful to all of our Coles County Dragway crew as we make these adjustments in order to be open and operable for the immediate future and duration of the 2020 season. Hopefully things will get back to normal, the farther we go into the season.
